

DECLARATION OF TRUST DEED

This Declaration of a Trust made this 17th day of May 2013 by M/s Hare Krishna Movement Hyderabad having its office at 8-2-684/250 , MLA Colony, Road #12, Banjara Hills, Hyderabad - 500034 (herein after referred as **HKMH**) registered with Registrar of Medak at Sanga Reddy bearing registration number 31 of Book No.4 represented by its Temple President, Satya Gaura Chandra Dasa a.k.a J V V Satyanarayana aged 42 years, son of late J Subbarao, residing at 8-2-684/250, MLA Colony, Road #12, Banjara Hills, Hyderabad - 500034, in pursuance of resolution of the Board of Trustees of the Hare Krishna Movement, Hyderabad passed by a circular resolution on 15th May, 2013 settling an amount of Rs.501/- (Rupees Five Hundred and One only) for a Public Charitable Trust created by this indenture of declaration subject to terms and conditions herein set forth.



AND WHEREAS the declaration and the terms and conditions subject to which the declaration is made is desired to be reduced to writing.

NOW THIS DEED WITNESSETH AS UNDER:


1. DECLARATION

That I, Sri. Satya Gaura Chandra Dasa also known as J.V.V. Satyanarayana, Temple President, HKMH, as authorized representative (Authorized vide circular resolution passed by the Board of Trustees of HKMH on 15.04.2013) of HKMH do hereby declare that we have irrevocably settled an amount of Rs.501 (Rupees Five Hundred and One Only) for the sole purpose that it should form the nucleus and corpus fund of the "**Hare Krishna Movement Charitable Foundation**" and that it has been accepted by the Trustees who have consented to act as Trustees subject to the conditions hereinafter stated.

2. NAME

Name of the Trust shall be "**Hare Krishna Movement Charitable Foundation**" or "**HKM Charitable Foundation**" or "**HKMCF**". The name of the Trust along with complete address of the Principal Office be used or mentioned in legible characters in all the business letters, bill heads, letter papers and in all its notices and other official publications.

The Principal Office of the Trust shall be at C/o Akshaya Patra Foundation, Sri Krishna Goseva Mandal, Narsingi Village, Kokapet Road, Hyderabad – 500171 or such other place as may be found suitable from time to time and so amended by way of a two-third majority in the meeting of the Board of Trustees.

The Trust shall also have offices at such other places as may be necessary for achieving the objects of the Trust.

4. OBJECTS

(i) To engage in providing education for promotion of moral, social, cultural, economic values of society / public at large and in furtherance of this object:

- (a) To establish centers for learning, training, performance and exhibition of Indian forms of music, dance, theatre, art, sculptor, etc. (including contemporary and current adaptations) with the objective of enriching the cultural and ethical values and inspire rightful conduct among the general public and to build auditorium, theatres, multi-media theatre, lecture halls, convention halls and other appropriate infrastructure to support this cause;
- (b) To establish, maintain, run, develop, improve, extend, grant and donate to educational institutions, including schools for the promotion and practice of fine arts and to aid in every possible manner such schools, colleges, polytechnics and other educational institutions including institutions for the study of various schools of philosophy, vocational training centers, research centers and hostels for students pursuing their studies;
- (c) To institute studentship, scholarship, stipends, medals, prizes etc., to help and encourage deserving students and to provide monetary aid to students, scholars and teachers for the purpose of an towards the imparting of education;
- (d) To establish, maintain, develop and donate for the establishment, maintenance and development of book banks, libraries, museums and hostels; and
- (e) To organize, conduct and assist in the organizing and conducting lectures, seminars and symposia.

(ii) To engage in providing medical relief for general health of the members of society / public at large and in furtherance of this object:

- (a) To establish, maintain, run, develop, improve, extend, grant, donate to and aid in the establishment, maintenance, running, development, improvement and extension of hospitals, clinics, dispensaries, medical laboratories, including Indian system of medicine like Ayurveda,

siddha, Naturopathy, Yoga Practices and similar institutions affording treatment, care, rest, recuperation and other medical relief to the public.

(iii) To engage in providing relief to the poor and in furtherance of this object:

- (a) To construct community halls, rest houses etc., to feed and to give food, clothing and cash grants to the poor and to grant donation for the support of the inmates of orphanages, rescue and rehabilitation centers and similar institutions; and
- (b) To inculcate among the poor, needy and educated youth the advantages of self help and self employment and in this direction to provide succor and sustenance to them by way of training and employment opportunities by establishing and supporting, cottage industries.

(iv) To engage in other objects of general public utility necessary and incidental for the purpose of attainment of the abovementioned objects and in furtherance of this object:

- (a) To establish, run and aid old age homes, community centers, public halls, cultural centers, including auditoria;
- (b) To establish, run and maintain goshalas in order to create awareness among the general public about Methods of manufacturing organic manures, organic pesticides, cooking gas, power plants from cow dung and cow urine (Panchagavyam) and other the benefits, including economic, from cow protection;
- (c) To popularize the vegetable-grain diet under the approved methods in order that full value of protein, carbohydrate, fat and vitamin benefit may be derived therefrom and educating people from bad effects of Non Vegetarian foods and diseases caused due to consumption of such food, by way of setting up food labs, research centers, restaurants, food courts, etc.;
- (d) To provide shelters and homes to the general public, to set up theme parks related to Indian heritage & history and related amenities to benefit the general public;
- (e) To undertake civic enterprises which do not come in conflict with the ideals and missions of the Trust with all the principles in view which may be in the form of improving the sanitation in holy places of pilgrimage by providing drinking water, drainage or in the form of developing new spiritual townships designed to provide facilities for culturing the spiritual consciousness of public in general;
- (f) To deal in spiritual paraphernalia like incense, pictures, bhajan CDs, children's books on historical and ancient heroes of India, etc.;

- (g) To advance, transmit and spread the ethical and philosophical principles as revealed in the teachings of Bhagvad Gita and Srimad Bhagvatam and the doctrines and the observances which serve to promote and manifest the said ethical and philosophical principles;
 - (h) To enter into any venture on its own or as a joint venture in the form or mode with any person, firm, company, society or trust or anyone to promote any of the objects or purely as incidental or supportive to the objects;
 - (i) To acquire properties and construct buildings in furtherance of the objects of the Trust;
 - (j) To carry out such acts which aids in upliftment of downtrodden socially and economically, cure the society from superstitions and social evils and also to collaborate, assist and join with similar institutions for fulfilling the objects of the Trust;
- (v) To enter into any arrangement with any Government or authority supreme, public, municipal, local or otherwise, and to obtain from any such Government or authority any rights, concessions and privileges that may be conducive to the Trust's objects or any of them to carry out, exercise and comply with any such arrangements, rights, concessions and privileges.
- (vi) To engage in any activity in so far as it is necessary and incidental and supportive to the attainment of above objects of the Trust.

5. BENEFICIARIES

The benefits of the Trust will be available to the members of the public without any distinction of caste, community, creed, sex etc. The HKMH or Trustees or their families or relatives shall not derive any extra benefit at any time from the Trust Funds at any event, neither during existence of the Trust, except by reasonable remuneration to the Trustees as may be provided by the Trust in a meeting of the Board of Trustees, nor at any other time any property of the Trust will be distributed among or made over to the Board of Trustees.

6. GUIDING PRINCIPLES

The Trustees will formulate, publish, practice and enforce operating principles and code of conduct that will result in highest degree of transparency, ethical and moral principles, as well accountability in the functioning and all activities of the Trust so as to meet the objects of the Trust.

The property held by the Trust or hereby created shall be irrevocable.

- (a) The term Trust Property shall be and include the schedule property set apart by the HKMH and further grants, donations and contributions and / or property movable or immovable that may be made by the HKMH or by the others from time to time and other accumulations and accretions thereof in whatever form they may be varied from time to time.
- (b) The Trust Property shall vest in the Board of Trustees who shall hold, manage and administer the Trust in accordance with the terms and provisions thereof.
- (c) No person shall, as a matter of right, demand any benefit from the Trust whether in the form of money, concessions, privileges, property of any kind or a share in the income of the Trust or otherwise.

8. TRUSTEES

- (i) The Trustees can either be voluntary, full-time, life-dedicated and initiated missionaries or shall be initiated disciples of Srila Prabhupada - all serving the mission of His Divine Grace A.C.Bhaktivedanta Swami Prabhupada in good standing and who accept that His Divine Grace A.C.Bhaktivedanta Swami Prabhupada as the initiating spiritual master for all times as per the direction given in the document titled "To All Temple Presidents and GBC" dated July 9th, 1977 and approved by His Divine Grace A.C.Bhaktivedanta Swami Prabhupada.
- (ii) **The First Trustees are:**
 - (a) Sri Chanchalapathi Dasa a.k.a Sri. S Chandrashekar
 - (b) Sri Amittasana Dasa a.k.a Sri. Amit Chabra
 - (c) Sri Satya Gaura Chandra Dasa a.k.a Sri J.V.V. Satyanarayana
 - (d) Sri Vasudev Keshav Dasa a.k.a Sri. Vishal Kumar Agarwal
 - (e) Sri Ratnangada Govinda Dasa a.k.a Raghunath Pawar
- (iii) **Board of Trustees**

All the Trustees will be collectively known as the Board of Trustees.
- (iv) **Appointment and Removal of Trustees**

The Board of Trustees shall co-opt any person, who has been nominated / recommended by the Governing Body Commission of GBC Society of Hare Krishna Movement (a society registered with Registrar of Societies, Uttar Pradesh bearing registration number S.No.2169/2011-12 having its registered office at Sri Radha Vrindavan Chandra Mandir, Chhattikara Road, Vrindavan, 281121 and hereinafter referred to as "GBC Society"), as Trustee.

Similarly, the Board of Trustees shall remove any trustee, as recommended by the Governing Body Commission of GBC Society of Hare Krishna Movement. However, the total number of Trustees shall at no time exceed ten and shall never be less than four.

(v) Resignation / Retirement of Trustees

Any of the Trustees may resign / retire after giving 30 days notice in writing regarding his intention to do so to the Board of Trustees and upon completion of the said 30 days he shall ipso-facto cease to be the Trustee of the Trust.

(vi) Executive Management Council

The Board of Trustees may constitute an Executive Management Council to conduct the day to day affairs of the Trust and delegate such powers for this purpose as are necessary and expeditious and for this purpose appoint a President and any other officer(s) to that Council.

However, no person shall be appointed as President unless such person has been approved for being so appointed by the Governing Body Commission of GBC Society. Further, only such persons shall appointed as other officers of the Executive Management Council as are recommended by the President.

The Executive Management Council shall work under the control and guidance of the Board of Trustees

(vii) Powers of the Trustees

Without prejudice to the generality of the powers, the Board of Trustees shall have the following powers for and towards the attainment of the objects of the Trust.

- (a)** To delegate any powers as they can lawfully delegate to any other person and to execute such power as they may think fit for the purpose;
- (b)** To appoint from time to time sub committees consisting of one or more trustee(s) and or one or more senior executives of the Trust to deal with such matters as they may deem fit and for this purpose may delegate any powers as they can lawfully delegate and revoke as and when felt necessary;
- (c)** To employ staff, agents, bankers, accountants, advocates, attorneys and others on such remuneration as they may think fit and to execute Power of Attorney etc. for and on behalf of the Trust;

- (d) To revoke any of the employments made under (c) above and withdraw the powers granted to such officials;
- (e) To implement highest degree of ethical & moral practices, Code of Conduct among its Trustees, Officers, Managers and other staff and take appropriate actions on violations;
- (f) To purchase or acquire by any other mode and let, sell or otherwise dispose off any movable property belonging to the Trust on such terms and conditions as they may think fit;
- (g) To purchase or acquire by any other mode and let any immovable property belonging to the Trust on such terms and conditions as they may think fit subject to prior approval of GBC Society;
- (h) To maintain bank accounts in the name of the Trust and authorize trustees and other officers of the Trust to operate the bank accounts subjects to such limits as may be prescribed;
- (i) To borrow moneys from Banks, Financial Institutions and others by mortgaging, hypothecating, charging or otherwise the immovable and / or movable properties of the Trust or stand as guarantor for borrowings from bank or any other financial institutions by any other public charitable trust with similar objectives. However all of these can be executed with approval of not less than three fourth majority of the Board of Trustees. Such resolutions will become effective only after approval by the GBC Society;
- (j) To accept and make gifts, donations, grants or contributions in so far as they are not inconsistent with the objects of the Trust;
- (k) To establish Trusts, Societies and any other institutions however only with the prior approval in writing of the Governing Body Commission of GBC SOCIETY;
- (l) To appoint proxy / proxies for voting at any of the meetings of Creditors, Contributories, Shareholders, stakeholders or otherwise;
- (m) To invest the Trust Funds in accordance with the provision of Section 11 (5) of the Income-tax Act, 1961 and further the Board of Trustees will ensure at all times having due regard to the provisions of Section 13 and other relevant provisions of the Income-tax Act, 1961 that the Income of the Trust will be exempt under the relevant provisions of that Act;

- (n) To sell or otherwise dispose any of the properties, excluding immovable property and including investments, of the Trust and re-invest or change the nature of investment to compound and settle any claims of or against the Trust;
- (o) To buy, sell, gift, convey, transfer, mortgage, alienate, lease for a period more than 3 years or otherwise dispose off any immovable property belonging to the Trust however only by a resolution of at least three fourths of the Board of Trustees and only provided that there is also prior approval in writing of the Governing Body Commission of the GBC Society;
- (p) To create Membership or Patronship or any other suitable schemes to advance the objectives of the trust.
- (q) The Board of Trustees may, by its resolutions enlarge, abridge, or alter the powers, rights, privileges, duties, functions and obligations or any of the office bearers by majority of the total number of Board of Trustees.
- (r) The Board of Trustees shall have all the powers to do any act, deed or thing in respect of which no specific provision act, deed or thing in respect of which no specific provision is made for under this deed which is found necessary for carrying out the purposes and objects of the Trust.
- (s) The power duties and functions of the Trustees and other not specified herein shall be governed by provisions of Indian Trust Act 1882 as may be applicable.

9. UTILISATION OF FUNDS

If the income from the Trust Property in particular year is not fully utilized, the unexpended income subject to the applicable provisions of the Income-Tax Act 1961, shall be carried over to the next year or years for the advancements of any of the object of the Trust and the funds/income of the Trust shall be solely utilized for achieving the objects of the Trust and no payment shall be made to the Trustees by way of profit/interest/dividend etc

10. ACCOUNTS & AUDIT

Accounts will be kept for the Trust and closed on 31st March of every year. Such accounts shall also be audited by a qualified Chartered Accountant within six months from the end of the accounting year, whose report shall be discussed and adopted by the Board of Trustees.

11. AMENDMENT TO THE TRUST

The Board of Trustees may from time to time make and prescribe additional Rules and Bye-laws for regulating the working, management and administration of the Trust and amend or delete any of them. The Board of Trustees will also have the power to carry out any amendments/deletions/additions to this Deed of Trust provided that the same is by a resolution of at least $\frac{3}{4}$ of the total number of Trustees and also provided that there is prior approval in writing of the GBC Body (Governing Body) of the GBC Society. The Trustees shall also be obliged to carry out any amendments/deletions, additions to the Trust Deed as may be directed by the GBC Body (Governing Body) of the GBC Society.

Provided that no such amendments carried out by the Trustees shall in any way alter or contravene the main objects of the Trust or the provisions of sections 2(15), 11, 12, and 13 of the Income Tax Act, 1961 as amended from time to time. Further no such amendments requiring prior approval of the Commissioner of Income Tax as required by the law for getting exemption under the Income Tax Act, 1961 as amended from time to time, shall be carried out without such prior approval of the Commissioner of Income Tax as applicable.

12. MEETINGS

The Board of Trustees shall conduct a minimum of one meeting in a year. All documents of the Trust shall be maintained by the Secretary of the Trust at its registered office.

Quorum of the Meeting

If the number of the Trustees is seven or less, presence of three trustees will form the Quorum of the meeting & the number of trustees is more than seven, presence of five trustees form the Quorum of the meeting.

All the resolutions passed at such meeting shall be by way of majority of the Trustees present and voting at the meeting. The procedure for the conduct of the meeting and issue of notices of the meeting and the place for such conduct including the method and manner of such conduct of meetings shall be at the sole discretion of the Board of Trustees.

The Board of Trustees can also conduct the meetings by way of video conferencing provided each person taking part in the meeting is able to hear and see each other taking part and provided further that each Trustee must acknowledge his presence for the purpose of the meeting and also vote at such meetings as if he was physically present.

Such resolution(s) shall be entered in the Minute Book of the Trust within thirty (30) days by the Secretary. All such resolution(s) shall be placed before the following meeting of the Board of Trustees.

In any meeting of the Board of Trustees including meeting by way of video conferencing or Circular Resolution, in the event of equality of votes, the Chairman elected for the meeting shall have the casting vote.

13. CHANGE OF NAME OF THE TRUST

The name of the Trust can be changed with the full consent of the Board of Trustees at any time in future in order to reflect to the general public accurately the affiliation relationship with the settler organization, HKMH.

14. INDEMNITY FOR TRUSTEES


Trustees will not be personally liable for any act *bona fide* done on behalf of the Trust in the course of duties as a Trustee.
